

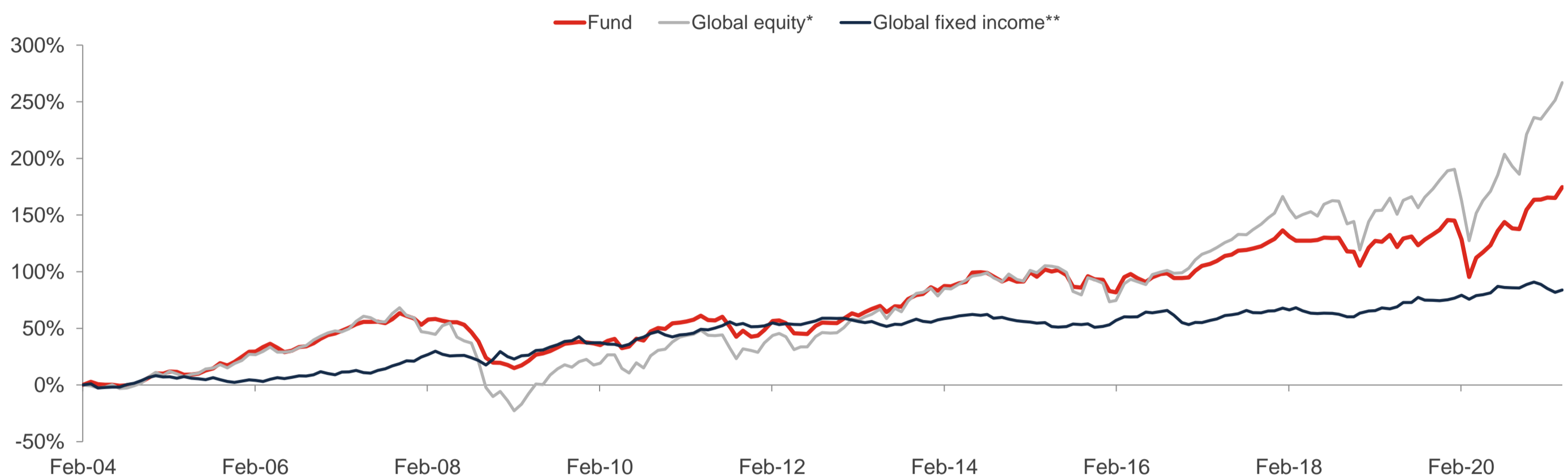
Fintax International Balanced Fund

Investment objective

The portfolio will retain a good level of diversification and will invest directly, or indirectly, into a wide range of asset classes that include cash, bonds, equities, alternative strategies, commodities and property. The investment of the Fund is not constrained to an asset allocation benchmark and will be actively managed to reduce risk.

Cumulative returns¹



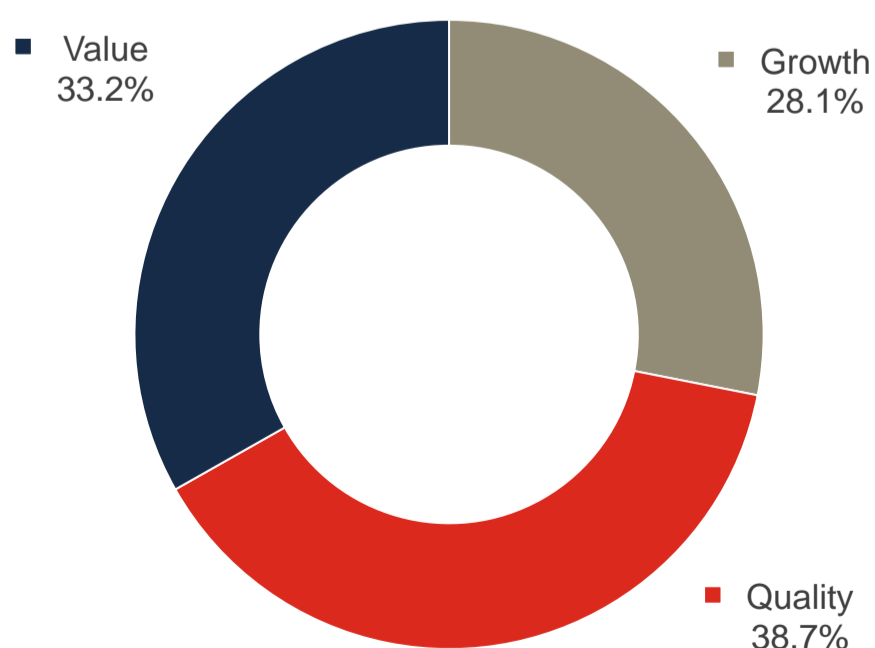

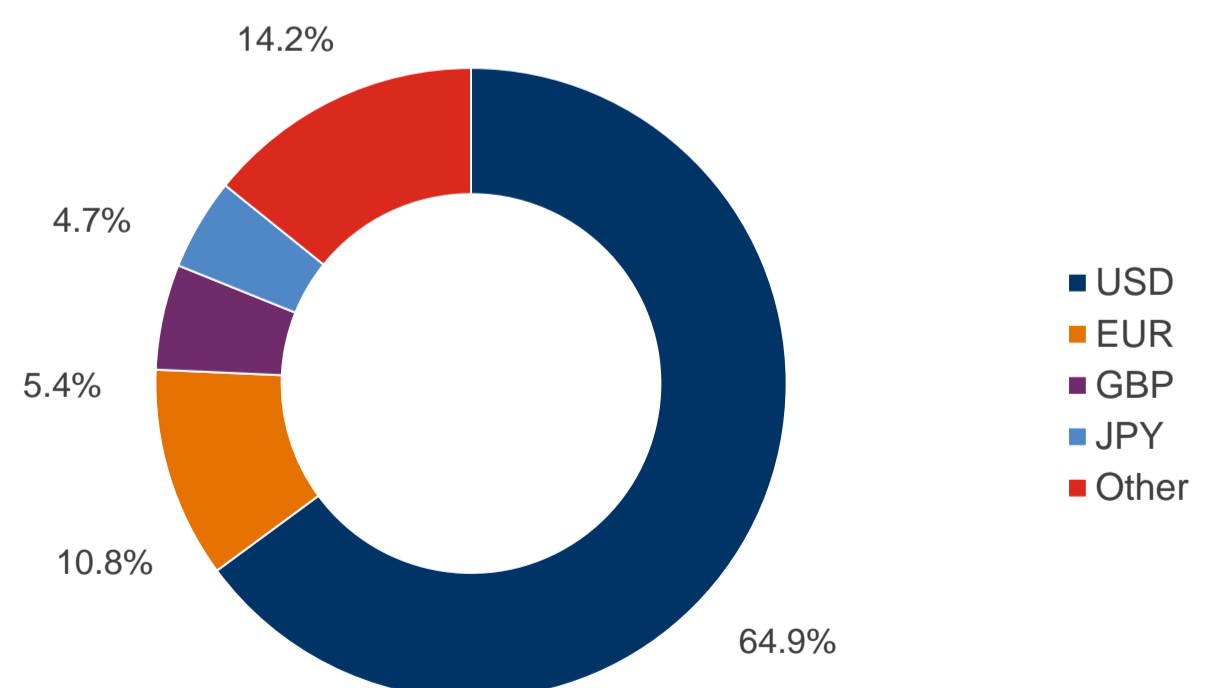
