Investment objective

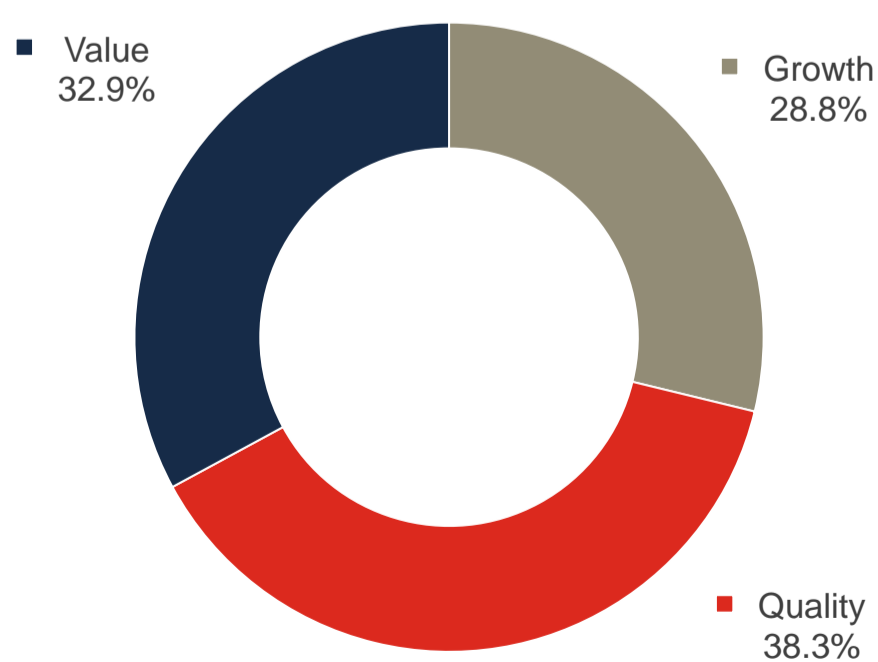

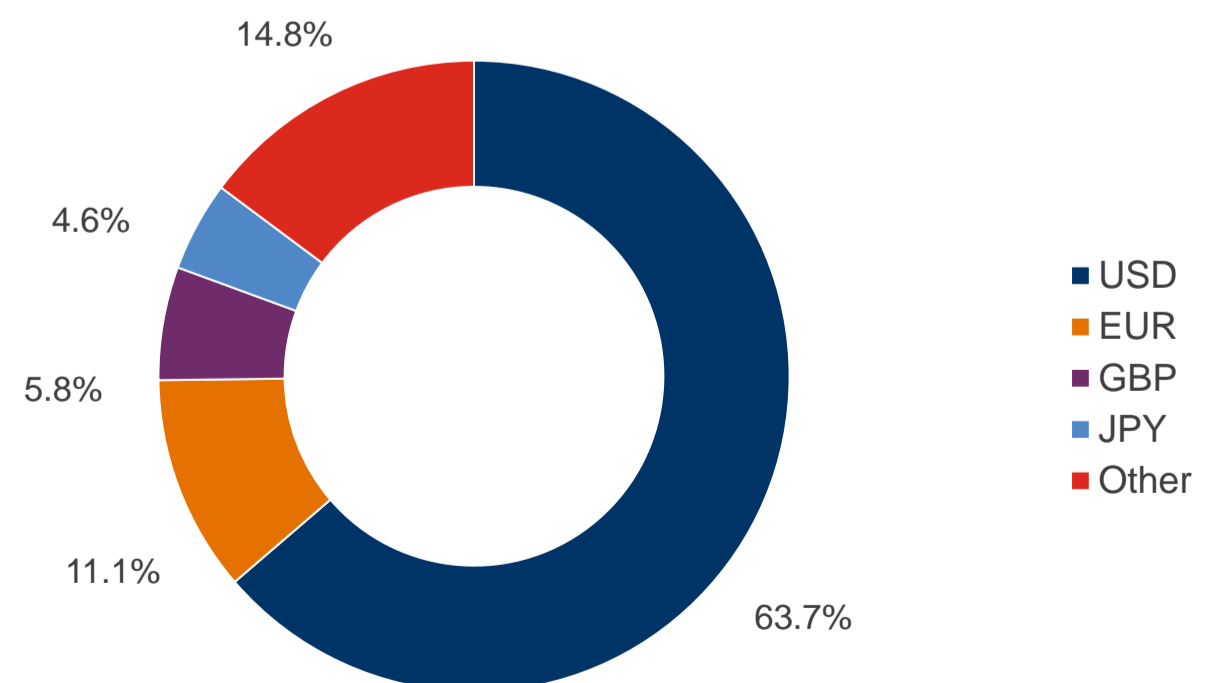
